Total Payment for Club Fees – Training and Field costs (please check):

- U15-U18 Teams (Fall only Season) - \$280 (plus team fees, see below)
- U09-U14 Teams (Fall and Spring) - \$560 (\$280 fall, \$280 spring – plus team fees, see below)

Total Payment for Team Fees – Team and Misc costs (please check):

- Estimated Team Fees (includes team and player registration, coaches travel fee, fundraising commitment, tournament costs, referee costs, and misc team costs) - \$155 per Fall/Spring session (est)

Individuals are responsible for their own travel expenses and the cost of uniform kits / training kits. The club will use the 09/10 uniform for the 10/11 season so if you played last year, you should not need to buy a uniform kit (\$105 est).

Player's Fees

1. A Player's Total Fees include Club and Team Fees/costs.
2. Payments are to be made by this schedule:
 - June 1st - \$100 (Team Fees)
 - July 1st - \$100 (U17 and below), \$150 (U18 aged players)
 - August 1st - \$100 (U17 and below), \$150 (U18 aged players)
 - September 1st - \$100 (U17 and below), \$Final (U18 aged players)
 - \$Final October 1st
3. The July and August payment MUST be paid before a player will be issued a player card.
4. Any nonpayment in excess of 30 days may result in a surrender of a player's card. Players will not be allowed to practice, play games or participate in Lakelands Toros activities until all outstanding fees have been paid.

Parent/Guardian Responsibilities

A parent or legal guardian of each player must agree to the following financial obligations.

1. As a parent or legal guardian of the above named player, I acknowledge that I have read and understand the player's Club Dues, payment schedule and am financially responsible for the fees stated about for the entire playing season. Refunds, less the initial Registration Fee and costs to date, will only be issued for a season-ending injury or for moving out of the area.
2. I agree to pay Lakelands Toros Soccer Club (through my team) as I have stated above by the deadlines shown, unless the Treasurer has approved a written request for late payment in advance of the due date.
3. I understand that once I sign this Commitment, I am bound to make ALL payments shown above. I also acknowledge and appreciate the importance of making these payments in a timely manner to enable the Club and Team to cover league expenses and associated expenses on a timely basis.
4. I understand that if I request a transfer to another club during the seasonal year, I must fulfill all financial obligations to Lakelands Toros Soccer Club and my Team before the transfer papers will be signed.
5. Financial Aid is available for those families truly in need. Please contact the club via a website and go online for an application. All financial aid applications MUST be submitted by June 1, 2010.
